| S23/15 Welcome and apologies | |
| S23/15.1 Apologies were received from Lyndsey Campbell-Williams and Geoff Ryall-Harvey. | |

| S23/15.2 The Chair commented that Clare Budden is no longer the Chair or a member of the SRG as she has taken a new role as Independent Member for the Health Board. The Chair wished Clare well and thanked her for her efforts | |

| with the SRG. The Chair raised that Laura Jones will no longer be secretariat to the SRG and welcomed Rebecca Hulme who will be taking over the SRG secretariat role from Laura. | |

| S23/15.3 The Chair made reference to the Health Board being back in Special Measures since February and that there have been a number of changes made to the Independent Members of the Board. | |
| S23/16 Declarations of Interest | |

| S23/17 Draft notes of the meeting held on 05.12.22 and summary action plan | |
| S23/17.1 The minutes were agreed as an accurate record. | |
| S23/17.2 Reference S22/38.3. The Chair raised the Well North Wales Programme business case had been developed and wanted it noted that we need to be updated. | |
| S23/17.3 Reference S22/42.1. The Chair reminded the Group to highlight any topics they would wish to be included. | |
| S23/17.4 The Chair requested the Group raise issues they would like the board to instigate and to reflect upon what the Group is here to do. The North Wales Hospice representative commented there were a lot of issues covered at the workshop, but there is a concern on where the follow up is which has been the criticism of the Group in the past. | |
| S23/17.5 The Interim Chief Executive introduced herself to the Group and commented their keenness to ensure we have Stakeholder influence in the business of the NHS in North Wales. | |
| S23/18 EASC Air Ambulance Update (Stephen Harrhy) | |
| S23/18.1 The Chief Ambulance Service Commissioner for NHS Wales gave a presentation on the Emergency Medical Retrieval and Transfer Service (EMRTS Cymru) and the Wales Air Ambulance Charity (WAAC) Service Review. The presentation provided an overview of EMRTS, where they are in their current review and to pick up any questions or comments from the Group. The Anglesey County Council representative raised the deep concern that they are cut off and the Air Ambulance is essential. The Chief Ambulance Service Commissioner confirmed they are looking to improve services in areas, not reduce services. The Flintshire County Council Representative asked if all air ambulances carry a full medical team. The Chief Ambulance Service Commissioner confirmed part of the role of the desk in the ambulance control is to send the right resource to the right call, which could also be upgraded at any time. The North Wales Hospices representative asked for a comparison on which bases are busier. The Chief Ambulance Service | |

Commissioner confirmed the South Wales base is busier than North Wales but this is expected due to the base being open 24 hours and commented that rural areas are more reliant on the service than urban areas.

S23/18.2 The North Wales Hospices representative raised the centralisation of a base and the rapid response times. The Chief Ambulance Service Commissioner confirmed weather conditions are really important and will form part of the review, additionally the rapid response vehicle does serve urban populations better. The AVOW Wrexham Third Sector representative asked if a mapping exercise had been completed and if the figures would be made public. The Chief Ambulance Service Commissioner confirmed the information would be made publicly available. The AVOW Wrexham Third Sector representative asked if the review included the response times of the rapid response vehicle if that was deployed rather than a helicopter. The Chief Ambulance Service Commissioner confirmed the times for both the rapid response vehicle and aircraft are recorded and will be included in the information to the public. The Welsh Ambulance Services Trust representative echoed support and expressed a level of reassurance to the Group to confirm they work really well with the EMRTS. The Chair commented on the possible extension to flying hours regarding night flying and whether that would accommodate the 3 that they are presently missing per day. The Chief Ambulance Service Commissioner responded that they will know once the analysis on the data had been completed.

S23/19 Special Measures (Geraint Parry)

S23/19.1 The Quality Improvement Fellow representative gave a presentation on Special Measures. The presentation provided an overview of progress in the Health Board in collaboration with Welsh Government. The Anglesey County Council representative asked how improvement was going to be measured so the public know we are moving in the right direction. The Quality Improvement Fellow representative confirmed measurements are actively being discussed and focused on putting a measurement framework in place. The AVOW Wrexham Third Sector representative requested for transparency, honesty and engagement with the public at every level. The Quality Improvement Fellow representative stated that a communications plan is being developed including patient and staff groups, committing to difficult conversations ensuring we are honest and transparent to build trust and confidence. . The North Wales Hospices representative commented that evidence is needed to show progress. The Quality Improvement Fellow representative confirmed the need for continual communication and to address items raised in the public domain.

S23/19.2 The Flintshire County Council representative commented that staff do not feel valued and will not strive to try to change things and the front door should be more accessible to the public. The communication is not there and there is no sight of the Special Measures deliverables. The Quality Improvement Fellow representative confirmed to committing to wanting to share and asked the Group to what level and what frequency the information is required and how could the Group help get the information out there. The

| Special Measures deliverables are included in our board papers on our website. The Chair highlighted the board meeting papers are in excess of 1500-2000 pages and trying to find something is not easy. The Flintshire County Council representative asked why BCUHB are not using social media and publishing a weekly bulletin with positive news. The Quality Improvement Fellow representative committed to sharing the deliverables with the Group. | GP |

| S23/19.3 The Director of Partnerships, Communications & Engagement representative thanked the Group for their feedback and reiterated it is really important to hear from our colleagues who are important Stakeholders. Statistics for last year highlights include 155 press releases, weekly bulletins to partners and politicians as well as dipping into Facebook pages in communities where we can, we have a new Chairman and Chief Executive and there is a drive to do this better. The Chair mentioned there is a matrix for improvement and asked what the Health Board does when the buildings are not fit for service. The Quality Improvement Fellow representative confirmed work is evolving as we move into Special Measures and there is clear executive ownership of the deliverables we are working to with various levels of checks, challenges, accountability and scrutiny. There are significant challenges in terms of the capital and the estates and part of that is with our board assurance framework. The Communications and Engagement Manager representative provided an introduction and explained to the Group the role is dedicated to Special Measures and the Comms and Engagement plan will be shared with the Group for comments. | SSJ |

The Chair commented that communication and engagement needed to be improved and transparency is vital. The Chair commented that members felt progress is what the public wishes to see. The Flintshire County Council representative challenged whether the Group knew what the Special Measures deliverables are.
